



- Project Requirement of 25% LDBE Participation (Local Disadvantaged Business Enterprise)
- The Metropolitan Washington Airports Authority (Airports Authority), Department of Supplier Diversity is pleased to announce a new Supplier Diversity Management System. The new system allows vendors the ability to easily register with the Airports Authority's DBE/ACDBE and LDBE Programs, complete on-line applications for certification, update contact information, look-up certified firms as well as additional functionalities.

#### **Key features include:**

- Enhanced online Directory, with key-word search capabilities
- Track certification applications from submission to completion
- Electronic certification applications and renewal processes
- Effective November 1, 2016, all certification applications must be submitted through the new system. The Department of Supplier Diversity will not accept paper applications postmarked after October 31, 2016.

# PROGRAM SUBCONTRACTING REQUIREMENTS

- Aviation Owner Controlled Insurance Program (OCIP) includes coverage of:
  - On-Site General Liability Insurance
  - On-site Excess Liability Insurance
  - Pollution Liability
  - Builder's Risk
  - The Subcontractor is still responsible to provide evidence of off-site insurance coverages including but not limited to Automobile insurance, Professional Liability insurance and Workman's Compensation insurance (both on and off-site), etc.
- Construction Tradesman Minimum Wages Program
- MWAA Safety Program
- Turner Construction Standard Form of Agreement (Form 36 terms & conditions)


